### A note for the New Chirurgeon:

A new Chirurgeon serves as a Chirurgeon-in-Training for at least three events where you are observed providing care for a participant by a warranted Chirurgeon, or in cases where there are no other chirurgeons, the branch Seneschal or Knight-Marshal. This training period is necessary not to evaluate your skills as a first-aide provider. It is, rather, required to provide you an opportunity to demonstrate the ability to handle the circumstances that are unique to the SCA.

### The Responsibilities of every Warranted Chirurgeon and Chirurgeon-in-Training:

- Maintain current certifications and insure that copies are on file with the Kingdom Chirurgeon or the appropriate deputy.
- Send in Annual Reports on time, even if you were not active during that year. We recommend you keep a personal copy for one year.
- Coordinate with the Autocrat and Marshal-in-Charge when acting as Chirurgeon-in-Charge of an event. Send in the appropriate reports to the Kingdom Chirurgeon or the appropriate deputy within one (1) week of the event.
- Provide assistance as needed within the guidelines of, but not exceeding, Standard First aid and CPR. The SCA will not cover activities practiced beyond standard first aid. If you exceed this level, you must take off the Chirurgeon baldric and provide care under your own certifications.
